TENNIS MEMBERSHIP AGREEMENT

Member's Obligation: In consideration of my tennis membership at The Ritz-Carlton, Half Moon Bay, I hereby promise and agree to pay the following fees on an annual basis.

Annual dues in the amount of \$ _____ are payable upon signing the membership agreement.

Waiver of Claims: The member assumes the risk of physical activity with his/her own physical condition and acknowledges that he/she has received advice from his/her Doctor that he/she is capable of physical exercise such as that provided or that he/she will seek such advice or that he/she assumes the risk of proceeding without such notice. The Member at Member's sole risk shall undertake all exercises and use of all tennis facilities. The Ritz-Carlton, Half Moon Bay shall not be liable for any Members or their guests for injuries, damages, actions, or causes of action whatsoever, to person or property arising out of or connected with the use of any of the tennis facilities of The Ritz-Carlton, Half Moon Bay or premises where the same are located or arising out of acts of active or possible negligence on the part of The Ritz-Carlton, Half Moon Bay, its officers, employees or agents.

No Assumptions of Liability or Ownership: Charter shall charge no regular or special assessments charged to members. Only regular dues and accrued charges will be billed. Tennis membership at The Ritz-Carlton, Half Moon Bay implies no liability whatsoever other than the agreement to pay dues, any charges made by the member, family or member's guests, designated corporate member and the initiation fee. Tennis membership constitutes a conditional right of use and conveys no ownership or proprietary interest in The Ritz-Carlton, Half Moon Bay, its property or assets. The Ritz-Carlton, Half Moon Bay also assumes no liability for items left on the premises.

Rules: It is agreed that the tennis membership and all persons using the tennis courts hereunder are bound and shall comply with all rules and regulations of the tennis courts as they may be amended from time to time. Failure to do so may result in termination of the membership. A copy of the Tennis Rules & Regulations will be provided to each member.

Tennis Membership Privileges: The tennis membership provides access to the tennis courts only. Members have the ability to reserve courts for day or evening play, reserve the ball machine, rent equipment and take private or group instruction from the tennis professionals at the membership rate. Access to the swimming pool, fitness center and locker room are not included in the tennis membership.

Tennis Membership Definitions:

Single Memberships will be defined as one person and is non-transferable.

Family Memberships will be defined as husband, wife or legal partners living at the same address along with their children under the ages of 19. Once a child becomes 19 years of age he/she will no longer qualify to be part of a family membership.

Jr. Memberships will be defined as children 8 years old to 18 years old. Once a child becomes 19 years of age he/she will no longer qualify for a Jr. Membership.

Resignation: Should I decide to terminate my membership, I understand that I must notify The Ritz-Carlton, Half Moon Bay in writing, return all membership cards and pay my account balance in full.
